RESOLUTION NO. 2014-018

A RESOLUTION TO VACATE A PORTION OF CERTAIN ROAD(S)

WHEREAS, the Jefferson County Commission authorized notice of proposed vacation of a portion of certain road(s) in Jefferson County Kansas, described as follows:

Spinnaker Circle, Spinnaker Lane, South Jib Road, North Jib Road, Genoa Lane, Genoa Circle, and Reacher Circle in the Simedo Village Subdivision, as shown on the original plat of Simedo Village, dated October 29,1971; and

WHEREAS, the Notice of Public Hearing was published in the official county newspaper on June 6, 2013; and

WHEREAS, notice of the proposed vacation was mailed by certified mail, return receipt requested, to all landowners of record as required by K.S.A. 68-102 notifying said landowners of the intent to vacate a certain portion of the road(s) and their right to protest said vacation; and,

WHEREAS, a hearing was held on June 23, 2014 for anyone wishing to protest the vacation of said particular road(s), and,

WHEREAS, as a result of that hearing, the Jefferson County Commissioners voted to vacate the road(s) and allow Simedo Road to remain a privately maintained public road with maintenance to be provided by the owners of the properties accessed thereby, provided that, while county shall retain an easement for the purpose of providing a public road for public travel, such road shall not be owned by the county or adopted into the county road system.

BE IT THEREFORE RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF JEFFERSON COUNTY KANSAS:

That the following road(s) is/are not a public utility by reason of neglect, non-use, or inconvenience and that said road(s) is/are impassable and the necessity for said road(s) as a public utility does not justify the expenditure of the necessary funds to repair said road(s) or put the same in condition for public travel and therefore portion(s) of said road(s) is/are vacated as follows:

Spinnaker Circle, Spinnaker Lane, South Jib Road, North Jib Road, Genoa Lane, Genoa Circle, and Reacher Circle in the Simedo Village Subdivision, as shown on the original plat of Simedo Village, dated October 29,1971; and

This Resolution shall be in full force and effect following its passage by the Board of County Commissioners.

WHEREUPON, the Board of County Commissioners of Jefferson County Kansas passes and adopts this resolution in regular session, at its chambers in Oskaloosa, Jefferson County, Kansas on this 14th day of July, 2014.


