A RESOLUTION TO VACATE UTILITY EASEMENTS

WHEREAS, the Jefferson County Board of County Commissioners authorized notice of proposed vacation of utility easements on a parcel of land in Jefferson County Kansas, described as follows:

The public utility easements on the common lot line of Lots 50 and 51 of Block S, Lake Ridge Estates, a subdivision in Jefferson County, Kansas, according to the recorded plat thereof.

WHEREAS, the Notice of Public Hearing was published in the official county newspaper on October 16, 2014, constituting at least 20 days prior to the date of the hearing; and

WHEREAS, a hearing was held on November 10, 2014 for anyone wishing to protest the vacation of said utility easements; and

WHEREAS, as a result of that hearing, the Jefferson County Commissioners voted to vacate such utility easements;

BE IT THEREFORE RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF JEFFERSON COUNTY KANSAS:


That the public will suffer no loss or inconvenience and that no private rights will be injured or endangered by the vacation of the following utility easements:

The public utility easements on the common lot line of Lots 50 and 51 of Block S, Lake Ridge Estates, a subdivision in Jefferson County, Kansas, according to the recorded plat thereof.

This Resolution shall be in full force and effect following its passage by the Board of County Commissioners and its subsequent publication in the official county newspaper.

WHEREUPON, the Board of County Commissioners of Jefferson County Kansas passes and adopts this resolution in regular session, at its chambers in Oskaloosa, Jefferson County, Kansas on this 10th day of November, 2014.

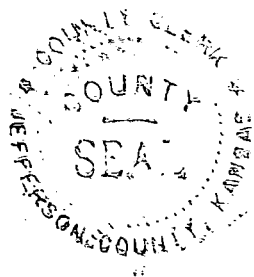

The public utility easements on the common lot line of Lots 50 and 51 of Block S, Lake Ridge Estates, a subdivision in Jefferson County, Kansas, according to the recorded plat thereof.

ORDER VACATING CERTAIN UTILITY EASEMENTS

The Jefferson County Board of County Commissioners met in regular session October 16, 2014. Commissioners Richard Malm, Wayne Ledbetter, Lynn Luck were present.

The Board upon its own motion made petition to vacate certain utility easements described as follows:

The public utility easements on the common lot line of Lots 50 and 51 of Block S, Lake Ridge Estates, a subdivision in Jefferson County, Kansas, according to the recorded plat thereof.

After hearing all testimony necessary in order to fully understand the true nature of the petition and propriety of granting the same,

THE BOARD OF COUNTY COMMISSIONERS HEREBY FIND:

1. That the Board of County Commissioners pursuant to K.S.A. 58-2613 has the authority to vacate utility easements within the county.
2. That due and legal notice has been given by publication as required by law, and the proof thereof has been duly made and filed as required.
3. That the public will suffer no loss or inconvenience by such vacation and that no private rights will be injured or endangered thereby.
4. That the utility easements described as follows should be vacated.

The public utility easements on the common lot line of Lots 50 and 51 of Block S, Lake Ridge Estates, a subdivision in Jefferson County, Kansas, according to the recorded plat thereof.

IT IS THEREFORE ORDERED, all three commissioners voting in the affirmative, that the following described utility easement, be vacated, to-wit:



That the County Clerk enter the proceedings concerning said vacation upon the records at length; that she certify a copy thereof to the Register of Deeds of Jefferson County, Kansas, all at the cost of the Petitioners.
