

RESOLUTION 2016- 022

A RESOLUTION AUTHORIZING THE CLERK OF THE DISTRICT COURT OF JEFFERSON COUNTY, KANSAS TO RELEASE PERSONAL PROPERTY TAX WARRANTS FOR THE TAX YEAR OF 1995 WHICH ARE NOW DORMANT AND UNCOLLECTABLE. (See KSA 79-2101 attached)

WHEREAS, the Clerk of the District Court of Jefferson County, Kansas has on file 1995 warrants evidencing delinquent personal property tax assessments and accrued interest and fees from the year of 1995.

WHEREAS, the Clerk of the District Court of Jefferson County, Kansas has issued warrants upon said delinquent taxes.

WHEREAS, Per KSA 79-2101 states: "any such judgment remaining uncollected after 20 years may be allowed to become dormant if the county commissioners determine after consideration of all relevant facts, that it is not reasonable to expect such judgment will be collected."

NOW THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Jefferson County, meeting in regular session this 29th day of August, 2016, does hereby resolve to authorize the Clerk of the District Court of Jefferson County, to discontinue issuing warrants for delinquent personal property taxes and interest and fees accrued for the year of 1995 and to release the tax liens for that year.

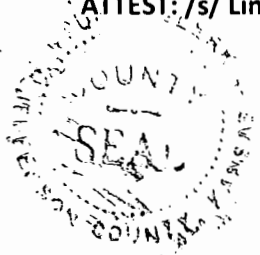
