

RESOLUTION 2017- 23

A RESOLUTION AUTHORIZING THE CLERK OF THE DISTRICT COURT OF JEFFERSON COUNTY, KANSAS TO RELEASE PERSONAL PROPERTY TAX WARRANTS FOR THE TAX YEAR OF 1996 WHICH ARE NOW DORMANT AND UNCOLLECTIBLE.

WHEREAS, the Clerk of the District Court of Jefferson County, Kansas now has on file 1996 abstracts and warrants evidencing delinquent personal property tax assessments, and accrued interest, for the year 1996.


WHEREAS, the Clerk of the District Court of Jefferson County, Kansas has issued warrants upon said delinquent taxes, and the accrued interest, at five year intervals and the statutory period has run for each year, and


WHEREAS, experience has clearly shown that such taxes are uncollectible, and the issuance of further warrants upon such delinquent taxes will constitute and economically unwise, useless, and cumbersome burden upon the facilities and staff of the Clerk of the District Court of Jefferson County, Kansas.


