

RESOLUTION 2009-20

A RESOLUTION AMENDING RESOLUITON 2009-17 RELATING TO THE CREATION OF A BOARD OF ZONING APPEALS FOR JEFFERSON COUNTY, KANSAS; APPOINTING PERSONS TO SERVE ON SAID BOARD OF ZONING APPEALS; SETTING LENGTH OF TERMS FOR SAID APPOINTEES; AND CALLING THE FIRST MEETING FOR SAID BOARD OF ZONING APPEALS.

WHEREAS, Kansas statutes authorize the Board of County Commissioners of Jefferson County, Kansas, to establish a Board of Zoning Appeals having a jurisdiction for all of Jefferson County, Kansas, except those lands within the incorporated cities;

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF JEFFERSON COUNTY, KANSAS, THAT:

Resolution No. 2009-17 is hereby amended to read as follows:

1. In accordance with Article 7, Chapter 12, of the Kansas Statutes Annotated, a Board of Zoning appeals for Jefferson County, Kansas, is hereby created. Said Board of Zoning Appeals shall consist of five (5) persons appointed by the Board of County Commissioners. Of the persons first appointed herein, one (1) shall be appointed for a term of one(1) year, two (2) shall be appointed for a term of two (2) years, and two (2) shall be appointed for a term of three (3) years. All persons appointed thereafter shall be appointed for a term of three (3) years. Vacancies shall be filled by appointment for the unexpired term. Persons appointed to the Board of Zoning Appeals shall serve without compensation for their service, but may receive reimbursement for expenses.
2. The following persons are hereby appointed to the Jefferson County Board of Zoning Appeals:
 - Dale Heston, shall be appointed for a term to expire in March 2010.
 - Jerry White, shall be appointed for a term to expire in March 2011.
 - Greg Hazen, shall be appointed for a term to expire in March 2012.
 - Robin Leach, shall be appointed for a term to expire in March 2012.
 - Stephen Phillips, shall be appointed for a term to expire in March 2011.
3. The Jefferson County Board of Zoning Appeals shall first meet no later than May 8, 2009; shall at said meeting select a Chairman and Vice-Chairman to serve a one (1) year term; and shall set a date and time for its regular monthly meeting. The Jefferson County Board of Zoning Appeals shall prepare by-laws to govern the conduct of the Board of Zoning Appeals business.
4. This resolution shall be in full force and effect from and after its passage and publication in the official County newspaper.
