

RESOLUTION 2009-22

A RESOLUTION ESTABLISHING A MAXIMUM SPEED LIMIT OF 45 MPH ON WEST LAKE ROAD FROM THE NORTH END OF BRIDGE NUMBER DACW 41-2-73-62 COMMONLY KNOWN AS THE D J MARINA BRIDGE TO A POINT WHERE THE WEST LAKE ROAD INTERSECTS WITH LAKE RIDGE AND FROM A POINT WHERE WEST LAKE ROAD INTERSECTS WITH LAKE RIDGE TO A POINT ON THE NORTH END OF BRIDGE NUBMER DACW 41-2-73-62 COMMONLY KNOWN AS THE D J MARINA BRIDGE, ALL BEING WITHIN RURAL JEFFERSON COUNTY, KANSAS.

WHEREAS, the Board of County Commissioners of the County of Jefferson, Kansas has the authority to regulate, warn and guide traffic upon all streets, road and highways under its jurisdiction; and

WHEREAS, based on the interest of public safety, the County Commissioners of Jefferson County Kansas have determined that it would enhance public safety to establish a maxim speed limit of 45 MPH on West Lake Road from the North end of Bridge Number DACW 41-2-73-62 Commonly known as the D J MARINA BRIDGE on West Lake Road to a point where the West Lake Road intersects with Lake Ridge AND from a point where Lake Ridge intersects with West lake Road to a point on the North end of the Bridge Number DACW 41-2-73-62 commonly known as the D J MARINA BRIDGE, Jefferson County, Kansas;

IT IS THE FINDING AND RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS that, in the interest of public safety, that a maximum speed limit of 45 MPH on West Lake Road from the North end of Bridge Number DACW 41-2-73-62 commonly known as the D J MARINA BRIDGE on West Lake Road to a point where the West Lake Road intersects with Lake Ridge AND from a point where Lake Ridge intersects with West Lake Road on the North end of Bridge Number DACW 41-2-73-62 commonly known as the DJ MARINA BRIDGE, Jefferson County, Kansas and that signs designating said speed limit be posted by Jefferson County Highway Department in appropriate locations.

This resolution shall become effective upon publication in the official county newspaper and posting of said signs.
