RESOLUTION NO. 2021-017

A RESOLUTION TO VACATE A PORTION OF CERTAIN ROAD(S) AND UTILITY EASEMENTS

WHEREAS, the Jefferson County Commission authorized notice of proposed vacation of a portion of certain road(s) in Jefferson County Kansas, described as follows:

All road rights-of-way located on all of that portion of Washington St. in the original town of Dunavant running from Fifth Street to the Southwest Boundary of the original town of Dunavant, Jefferson County, Kansas.

WHEREAS, the Notice of Public Hearing was published in the official county newspaper on May 27, 2021;

WHEREAS, notice of the proposed vacation was provided to all landowners of record as required by K.S.A. 68-102 notifying said landowners of the intent to vacate a certain portion of the road(s) and their right to protest said vacation; and,

WHEREAS, a hearing was held on July 12, 2021, for anyone wishing to protest the vacation of said particular road(s), and,

WHEREAS, as a result of that hearing, the Jefferson County Commissioners voted to vacate a certain portion of the road(s).

BE IT THEREFORE RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF JEFFERSON COUNTY KANSAS:

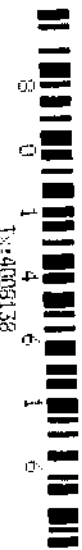
That the following road(s) and utility easements are no longer a public utility by reason of neglect, non-use, or inconvenience and that said road(s) and utility easements are impassable and the necessity for said road(s) and utility easements as a public utility does not justify the expenditure of the necessary funds to repair said road(s) and utility easements or put the same in condition for public travel and therefore portion(s) of said road(s) is/are vacated as follows:

All road rights-of-way located on all of that portion of Washington St. in the original town of Dunavant running from Fifth Street to the Southwest Boundary of the original town of Dunavant, Jefferson County, Kansas.

This Resolution shall be in full force and effect following its passage by the Board of County Commissioners and its subsequent publication in the official county newspaper.

WHEREUPON, the Board of County Commissioners of Jefferson County Kansas passes and adopts this resolution in regular session, at its chambers in Oskaloosa, Jefferson County, Kansas on this 19th day of July, 2021.
